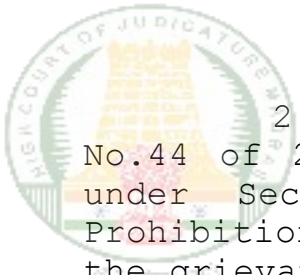

The petitioner is the defacto complainant in Crime No.44 of 2018, which was registered for the offences punishable under Sections 294(b), 506(ii) and Section 4 of Tamilnadu Prohibition of Charging Exorbitant Rate of interest Act 2003. Now the grievance of the petitioner is that even though after lapse of three years, investigation the above said crime number has not been completed.
