Prayer in WP(MD). 7755/ 2019 :

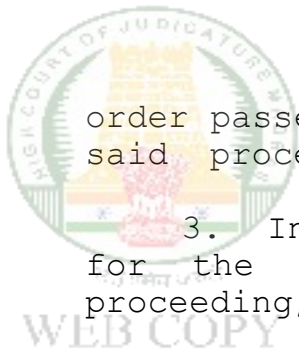
