PRAYER :-

For Anticipatory bail in Crime No.236 of 2021 on the file of
the Respondent Police.

ORDER : The Court made the following order :-

The petitioner, who apprehends arrest at the hands of the
respondent police for the alleged offences punishable under Sections
406, 465, 468, 471 of IPC and Section 12(1)(b) of Passport Act, 1967
in Crime No.236 of 2021, seeks anticipatory bail.

2. This is the fourth anticipatory bail petition filed by the
petitioner and the earlier petitions filed by the petitioner in
Crl.O.P(MD) Nos.6670, 9402 and 11656 of 2021 were dismissed on
03.06.2021, 15.07.2021 and 02.09.2021, respectively after
elaborately considering the points raised by the petitioner.



3. Since the dismissal of the earlier petitions, there is no change in circumstances in the case to consider the present petition. Hence this Court is not inclined to grant anticipatory bail to the petitioner.
