PRAYER :-For Anticipatory Bail in Crime No. 886 of 2021 on the file of the respondent police.

ORDER : The Court made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police for the alleged offences punishable under Section 379 of IPC and Section 21(4) of Mines & Minerals (Development & Regulation) Act, 1957, in Crime No.886 of 2021, seeks anticipatory bail.
