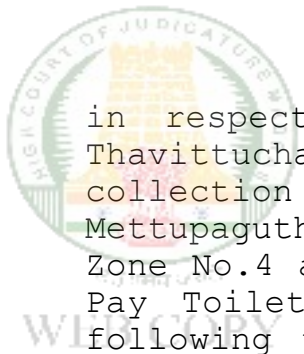

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a WRIT OF MANDAMUS or order of direction in the nature of writ to directing the 1 to 3 respondents to cancel the illegal tender and to conduct a fresh tender/re-tender



in respect of item No.12 related to collection of charges in Thavittuchanthi Market in Zone No.3 item No.6,8 and 9 related to collection of charges in Jeyhindpuram Daily Market, Thirunagar Mettupaguthi Weekly Market (Tuesday) and Subramaniayapuram Market in Zone No.4 and Item No.13 related to collection of charges in Public Pay Toilet nearby Old Ramnad collector Office in Zone No.2, by following the due procedures as contemplated under the Tamil Nadu Tender Transparency Act and Rules, by considering the representation sent by this petitioner dated 27.08.2021 and 06.09.2021.
