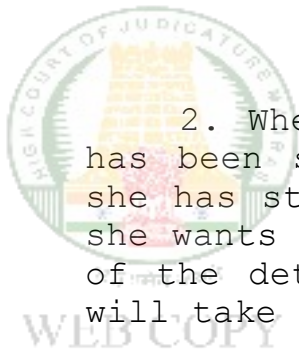

O R D E R

(Order of the Court was made by **V.BHARATHIDASAN, J.**)

Alleging that the petitioner's daughter by name Chitradevi, aged about 15 years, found missing from 02.09.2021 and suspecting that the third respondent has abducted her, the petitioner has given a complaint before the second respondent police. But, so far no action has been taken to secure the detenu. Hence, the present Habeas Corpus Petition.



2. When the matter is taken up for hearing today, the detenu has been secured and produced before this Court and on enquiry, she has stated that she gone to Tirupur and working there and now she wants to go with her mother, the petitioner herein. The mother of the detenu also present before this Court and stated that she will take care of the detenu.

3. Mr.S.Ravi, learned Additional Public Prosecutor appearing for the State, on instructions would submit that the third respondent was arrested and remanded to judicial custody.

4. Considering the fact that the detenu has been secured and handed over to the petitioner, no further adjudication is required in this matter. Hence, the Habeas Corpus Petition is closed.
