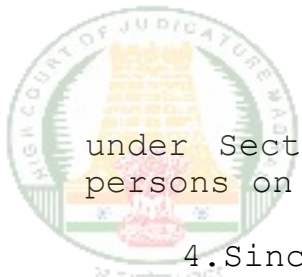

This petition is filed seeking direction to the respondents to register the First Information Report, on the basis of the order passed in Crl.M.P.No.1650 of 2021 dated 07.05.2021.

2.The grievance of the petitioner herein is that even though 4 months lapsed, no FIR has been registered on the basis of the direction issued by the concerned jurisdictional Magistrate Court.

3.The learned Government Advocate (Crl.Side) for the respondents would submit that based upon the direction, a case in 2021 was registered for the offences punishable



under Sections 147, 294(b), 427, 323 and 506(i) of IPC against 5 persons on 22.09.2021.

4.Since First Information Report has been registered, nothing survives for further consideration or direction in this petition.

5.This petition is dismissed as infructuous, accordingly.
