This Criminal Original Petition is filed to quash the First Information Report in Crime No.319 of 2021, on the file of the first respondent police for the offences punishable under Sections 147, 148, 294(b), 352, 506(ii) IPC and Section 4 of Tamil Nadu Prohibition of Harassment of Women Act, 2002.

2.The second respondent / defacto complainant as well as the petitioners/accused are present before this Court through video conference and they are identified by the respective learned counsel and both the parties have filed joint compromise memo stating that the matters in issue between them has been amicably resolved and therefore, the second respondent / defacto complainant is not willing to prosecute the case and therefore would pray for quashing the case.
