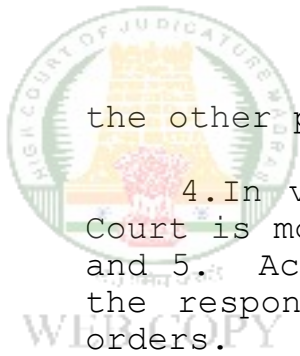

This petition has been filed to relax the condition imposed against the petitioners in Crl.O.P.No.11888 of 2021, dated 19.08.2021.

2.The learned counsel for the petitioners would submit that the petitioners are complying with the condition from 06.09.2021, without fail.

3.The learned Government Advocate would submit that the petitioners 2 and 3 are complying with the condition regularly, but,

6. Accordingly, this criminal original petition is partly allowed .
