PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :-

For an Anticipatory Bail in Crime No.688 of 2021 on the file of the Respondent Police.

ORDER : The Court made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police for the alleged offences punishable under Sections 379 of IPC r/w Section 21(1) of Mines and Minerals (Development and Regulation) Act, 1957 in Crime No.688 of 2021, seeks anticipatory bail.

2. The prosecution case is that the petitioner has illegally transported 1/2 unit of sand by using TATA ACE. Hence, the complaint.

3.It is reported by the learned Additional Public Prosecutor that this is the second anticipatory bail application and the petitioner is having seven previous cases in Crime Nos.94 of 2016, 65 of 2014, 60 of 2016, 28 of 2017, 275 of 2017, 1389 of 2020, 369 of 2021, all filed in the file of the respondent Police.

4. Considering the nature of offence and the antecedents of the



petitioner, this Court is not inclined to grant anticipatory bail to the petitioner. Accordingly, this Criminal Original Petition is dismissed.
