ORDER

This petition is filed seeking a direction to the 1st respondent to instruct the 2nd respondent to conduct the speedy investigation in Crime No.1202 of 2020 for the offence under Section 25(1B)(b) of Arms Act pending on the file of the 2nd respondent and to file the final report.

2.The petitioner is the accused No.1 in Crime No.1202 of 2020 which was registered for the offences punishable under Section 25 (1B)(b) of Arms Act. The learned counsel for the petitioner submitted that since the petitioner is involved in other cases, he seeks speedy disposal of this case.

3.The learned Government Advocate (Crl.side) for the respondent would submit that within 3 months, investigation will be completed and the final report will be filed before the concerned court.

4.Recording the submission and accepting the request made by the learned Government Advocate (Crl.side), there shall be a direction to the respondent to complete the investigation and file a



find report within a period of 3 (three) months from the date of receipt of a copy of this order. After filing final report before the concerned court, compliance report must be submitted to the Registry.

5.This petition is disposed of, accordingly.
