PRAYER :-

For Anticipatory Bail in Crime No.731 of 2021 on the file of the respondent Police.

ORDER : The Court made the following order :-

The petitioners, who apprehend arrest at the hands of the respondent police for the alleged offence punishable under Section 379 of IPC and Section 21(4) of Mines & Minerals (Development & Regulation) Act, 1957, in Crime No.731 of 2020, seek__anticipatory bail.
