3.Having regard to the limited scope of the prayer in the Writ Petition, without expressing any opinion on the merits of the petitioner's case in the affidavit or the representation of the petitioner, this Court is inclined to pass the following direction:

3.1.The respondent is directed to consider the representation of the petitioner, dated 17.08.2021 and pass appropriate orders on merits and in accordance with law within a period of twelve weeks



from the date of receipt of a copy of this order.

4. With the above direction, the Writ Petition is disposed of.
