5.Since no complaint has been given or no enquiry is pending against this petitioner, the question of harassment at the hands of the 2nd respondent may not arise. However, if any trouble arises in future, she is at liberty to workout her remedy appropriately.

6.With the aforesaid liberty, this petition stands disposed of.
