4.Let the learned Judicial Magistrate No.VI, Tiruchirapalli summon the Investigation Officer, expedite the trial process in S.T.C.No. 459 of 2018 and dispose of the same on merits within a period of 2 months from the date of receipt of a copy of this order.



After disposing the same, compliance report must be submitted to the Registry.
