This criminal original petition has been filed for quashing the FIR in Crime No.525 of 2021 registered on the file of the first respondent.

2.The defacto complainant/Arumugam is present before this Court in person. He has been duly identified by Mr.M.Murugan, Head Constable, attached to first respondent police station. The parties have filed a memo of joint compromise dated 06.12.2021. The defacto complainant categorically states before this Court that he does not want to pursue the complaint. When the parties have arrived at an amicable settlement and the defacto complainant does not want to pursue the complaint, no purpose will be served in keeping the impugned prosecution alive. The impugned FIR is



quashed. The criminal original petition is allowed. Consequently, connected miscellaneous petition is closed.
