The petitioner, who apprehends arrest at the hands of the respondent police for the alleged offences punishable under Section 379 of IPC and Section 21(4) of Mines & Minerals (Development & Regulation) Act, 1957, in Crime No.412 of 2020, seeks__anticipatory bail.

2.It is reported by the learned Government Advocate (Criminal Side) that the petitioner is having three previous cases in his credits. The details of the previous cases are as follows:

3. Considering the nature of offence and the antecedents of the petitioner, this Court is not inclined to grant anticipatory bail to the petitioner. Accordingly, this Criminal Original Petition is dismissed.
