PRAYER IN SA(MD)SR.NO.88973 of 2019

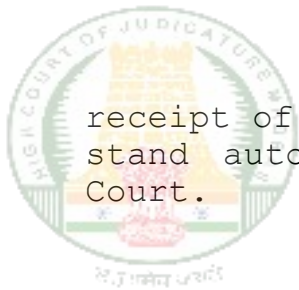
