PRAYER :-

For Anticipatory Bail in Crime No.2107 of 2021 on the file of the Respondent Police.

ORDER : The Court made the following order :

The petitioner apprehending arrest at the hands of the respondent police for the offence punishable under Sections 406, 465 and 506(i)IPC, in Crime No.2107 of 2019, seeks anticipatory bail.

5.It is seen that the final report has been filed and taken on file in C.C.No.667 of 2021, on the file of the learned Judicial Magistrate No.II, Madurai and the petitioner has also appeared before the Court on 18.10.2021.

6.In view of the above, no further order needs to be passed in this petition. Hence, this petition stands closed.
