The petitioner's grievance is that the respondent No.5 has encroached upon the Government land.



2.The learned Additional Government Pleader appearing for the respondents 1 to 3 and the learned standing counsel for the respondent No.4 submitted that encroachment has been found on inspection, in fact, even the petitioner has encroached.

3.If that is the case, the respondent Nos.3 and 4, as the case may be, shall take appropriate action to remove the encroachment, after making inspection. Needful shall be done within a period of eight weeks from the date of receipt of a copy of this order. We make it clear that there is no allegation as against the 5th respondent with regard to encroachment.

4. Accordingly, the writ petition stands disposed of. No costs.
