PETITION FOR BAIL Under Sec.439 of Cr.P.C

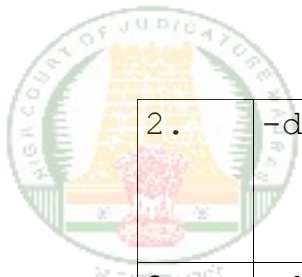
PRAYER :-For bail in Crime No.952 of 2021 on the file of the Respondent police.

ORDER : The Court made the following order :-

The petitioner/sole accused, who was arrested on 13.09.2021 for the alleged offence punishable under Sections 379 of IPC r/w 21(1) Mines and Minerals (Development & Regulation) Act, 1957, in Crime No.952 of 2021 on the file of the respondent police, seeks bail.

2. The learned Additional Public Prosecutor would submit that apart from this case, the petitioner has involved in nine cases, in which, three cases are similar in nature. The respondent police has given the data with regard to previous cases which reads as follows.
