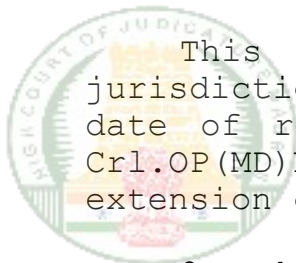
Prayer in CRL MP (MD) No. 7603 of 2020 :-
