They have been duly identified by Mr.M.Rex, the Sub Inspector of Police attached to Devakottai Town Police Station. A joint memo of compromise dated 17.11.2021 has also been filed. The defacto complainant does not want to pursue the complaint. When the parties have arrived at an amicable settlement and the defacto



complainant does not want to pursue the complaint, no purpose will be served in keeping the impugned prosecution alive. In the interest of justice, the impugned FIR is quashed and the criminal original petition is allowed.
