PETITION FOR BAIL Under Sec.439 of Cr.P.C.

PRAYER :-

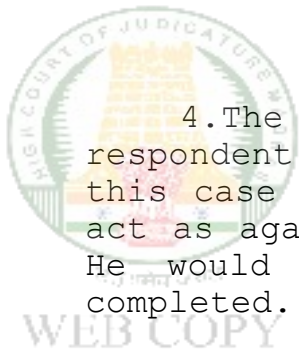
For Bail in Cr.No.305 of 2021 on the file of the Respondent Police.

ORDER : The Court made the following order :-

The petitioner/A5, who was arrested on 04.08.2021, for the offence punishable under Sections 147, 148, 120B, 294(b), 341 and 302 I.P.C., in Crime No.305 of 2021 on the file of the respondent Police, seeks bail.

2.The case of the prosecution is that the deceased and the accused are friends. Due to some quarrel between the deceased and the accused while consumption of drugs, the accused persons assaulted the deceased with sickle and caused his death. Hence, the complaint.

3.The learned counsel for the petitioner submits that due to lending of this petitioner's two wheeler to the accused no.4, the petitioner has been arrayed as an accused in this case. He further submits that the petitioner is an innocent and he has not committed any offence as alleged by the prosecution. He is inside the prison from 04.08.2021 and hence, he seeks for grant of bail.



4.The learned Additional Public Prosecutor appearing for the respondent police would submit that totally there are 8 accused in this case and the petitioner is arrayed as accused no.5. The overt act as against the petitioner is that he caught hold the deceased. He would further submit that the investigation is yet to be completed.

5.Considering the facts and circumstances of the case, the nature of allegation levelled as against the petitioner and also the period of incarceration, this Court is inclined to grant bail to the petitioner, however, with stringent conditions.

6. Accordingly, the Criminal Original Petition is ordered. The petitioner is directed to be released on bail on his executing a bond for a sum of Rs.25,000/-(Rupees Twenty Five Thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate No.I, Sivakasi and on further conditions that:

[a] the sureties shall affix their photographs and left thumb impression in the surety bond and the Magistrate may obtain a copy of their Aadhaar card or bank pass book to ensure their identity.

[b] the petitioner shall appear before the respondent police daily twice, ie. at 10.30 a.m. and 05.30 p.m until further orders.

[c] the petitioner shall not tamper with the evidence or witness either during investigation or trial.

[d] the petitioner shall not abscond either during investigation or trial.

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner is released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]**.

[f] If the accused thereafter absconds, a fresh FIR can be registered under Section 229-A IPC.
