4.Considering the grievance that has been expressed by this petitioner, since the investigation has been completed, the 2nd respondent is directed to file the final report within a period of 15 days from the date of receipt of a copy of this order, after completing the official formalities.



5.After filing the final report before the concerned court, compliance report must be submitted to the Registry.

6.This petition is allowed, accordingly.
