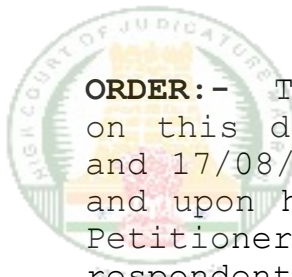

Prayer in Crl.M.P (MD) 7937/2021 :-

This Criminal Miscellaneous Petition filed under section 482 of the Criminal Procedure Code, Praying this Court to grant extension of time granted in the order made in Crl.M.P. (MD) No. 5948 of 2021 in Crl.O.P. (MD) No. 9763 of 2021, dated. 17.08.2021 on the file of this Hon`ble Court in connection with the case in Crime No. 626 of 2021 on the file of the 2nd Respondent Police.

Prayer in CRL OP (MD) . 9763/ 2021 :-

This Criminal Original Petition filed under section 482 of the Criminal Procedure Code, Praying this Court to direct the learned I Additional District and Session Judge (PCR) Court, Thanjavur to accept the surrender of the Petitioners and consider the Petitioners bail application and grant bail on the same date of surrender itself in Cr.No.626 of 2021.

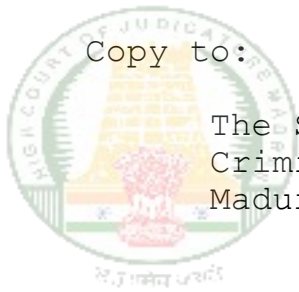
