4.Mr.V.R.Shanmuganathan, learned Standing counsel appearing for the respondents 1 & 2 on instructions, would fairly submit that the Teachers Recruitment Board after discussing issues, they are ready to issue necessary corrigendum to the Notification/Advertisement dated 09.09.2021.

5.The aforesaid statement of the learned Standing counsel appearing for the respondents 1 & 2 is recorded.

6.The learned counsel appearing for the petitioner has no serious objection on the aforesaid statement made by the learned Standing counsel appearing for the respondents 1 & 2.
