4. Considering the facts and circumstances of the case, the condition already imposed on the petitioner in Crl.O.P.No.12806 of 2021, dated 13.09.2021 is relaxed. However, the petitioner shall



report before the respondent police once in a week, i.e., on every Monday 10.30 a.m., and at 05.30 p.m., until further orders.
