J U D G M E N T

(Judgment of the Court was delivered by M.M.SUNDRESH, J)

Learned counsel appearing for the appellant submitted that after the order passed by the learned Single Judge in W.P.(MD) No.9888 of 2020, another representation has been made by the petitioner to respondent No.3 on 28.11.2020, which can be directed to be considered.

2.Mrs.S.Srimathy, learned Special Government Pleader, who takes notice on behalf of the respondents, on instructions submitted that the representation of the appellant, dated 28.11.2020, shall be considered by respondent No.2.

3.In such view of the matter, respondent No.3 is directed to forward the representation of the appellant, dated 28.11.2020, within four weeks from the date of receipt of a copy of this judgment and on receipt of the said communication, enclosing the copy of the representation made by the appellant, respondent No.2 shall consider the same and pass orders on merits and in accordance with law within six weeks therefrom.

4.The Writ Appeal is disposed of with the above directions.
