PRAYER IN SA(MD)SR.No.19012 of 2019:

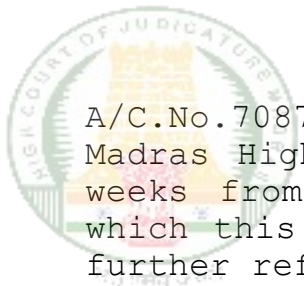
