This criminal original petition has been filed for quashing the First Information Report in Crime No.263 of 2021 registered on the file of the first respondent police station for the offences under Sections 324 and 506(ii) of I.P.C. and Section 4 of Tamil Nadu Prohibition of Harassment of Women Act 2002.

4. Therefore, the impugned First Information Report is quashed. This criminal original petition is allowed. The joint compromise memo filed by the parties shall form part of the decree. Consequently, connected miscellaneous petition is closed.
