2. Let an order in this regard be passed by the Tahsildar and communicated to the writ petitioners so that necessary proceedings can be initiated by the petitioners in furtherance to such order. The Tahsildar/fourth respondent is directed to pass necessary orders on or before 03.12.2021 and communicate the same to the petitioners herein. In view of that particular fact, these Writ Petitions are disposed of.

3. With the above observations, these Writ Petitions are disposed of. There shall be no order as to costs.

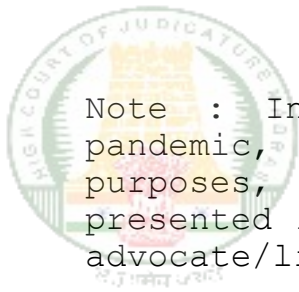
