For R1 to R3 : Mr.RMS.Sethuraman

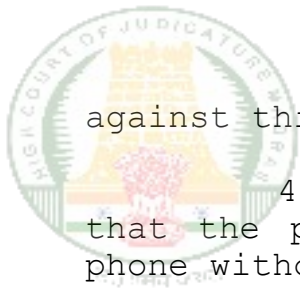

ORDER

4. But, the learned counsel for the petitioner would submit that the petitioner was called upon by the third respondent over phone without making any proper official complaint.
