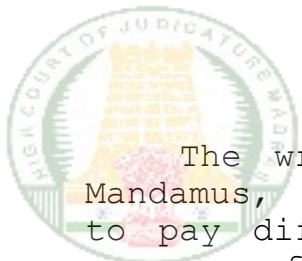

Prayer : Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the Respondents to revise petitioner pay and to pay difference in Earned Leave salary, S.L. Leave salary and arrears of pension from June 2016 to October 2019 together with interest at the rate of 18% per annum in terms of 7th pay commission recommendations for revision of pay and as per G.O.Ms.No:134 Transport(D) Department, dated: 09.04.2018 within the time limit that may be fixed by this Court and pass orders.

ORDER

The writ petition has been filed for issuance of a Writ of Mandamus, directing the Respondents to revise petitioner's pay and to pay difference in Earned Leave salary, Leave salary S.L. and arrears of pension from June 2016 to October 2019 together with interest at the rate of 18% per annum and also to pay the interest at the rate of 18% per annum on belated payment of Difference in Commuted Value Pension from June 2016 to October 2019 in terms of 7th pay commission recommendations by revising his pay and as per G.O.Ms.No:134 Transport(D) Department, dated: 09.04.2018.

2. According to the petitioner, the petitioner has made a representation to the respondents to revise the petitioner's pay and to pay Earned Leave Salary, Leave salary S.L and arrears of pension along with the interest.

3. According to the petitioner, similar writ petition has been filed before this Court in W.P.(MD) No.11390 of 2021 dated 09.07.2021 and this Court has passed an order directing the respondents to consider the petitioner's representation in the light of G.O.Ms.No.303, Finance (Pay Cell) Department, dated 11.10.2017 and G.O.Ms.No.134, Transport (D) Department, dated 09.04.2018 on its own merits.

4. The learned Standing Counsel appearing for the respondents has not disputed the said fact that an order being passed by this Court in the similar writ petition, directing the respondents to consider the petitioner's representation and pass appropriate orders.

5. In view of the above submissions made by the counsel for the parties concerned, this Court is inclined to direct the second respondent to consider the petitioner's representations dated 14.10.2020 & 15.04.2021 taking into account, both the aforesaid G.O.s and pass orders on its merits and in accordance with law as expeditiously as possible within a period of twelve (12) weeks from the date of receipt of a copy of this order.

6. With the above directions, the writ petition stands disposed of. There shall be no order as to costs.
