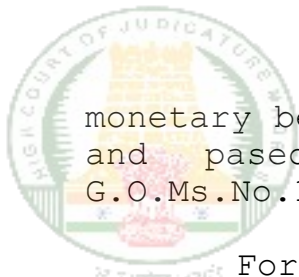

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a writ of Mandamus, directing the respondents to revise the petitioners Pay Notionally with effect from 01.01.2016 and to revise the his pension and other terminal benefits payable to him with effect from 01.10.2017 and also direct to pay the difference in terminal benefits such as Gratuity, Commuted value of pension and Leave salary etc. and also pension arrears with effect from 01.10.2017 together with interest at the rate of 12% per annum to till the date of payment of the said



monetary benefits based on the 151st Board meeting held on 28.08.2018 and passed resolution in Resolution No.58/2018-19, as per G.O.Ms.No.134 Transport [D] Department dated 09.04.2018.
