Prayer in CRL MP(MD). No.7415 of 2020:-

This court directed the petitioners to surrender before the Jurisdictional Special Court within a period of six weeks from the date of receipt of a copy of the order passed on 08.06.2020 in Crl.OP(MD)No.5734 of 2020. The petitioners have sought for further extension of two weeks.



2. This court is satisfied with the reasons stated by the petitioners and therefore, two weeks time is granted to surrender before the jurisdictional Special Court. Accordingly, this petition is ordered.
