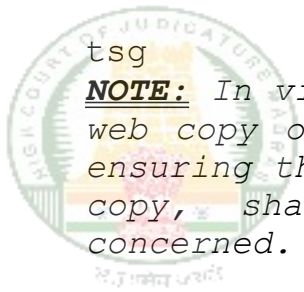
The matter was posted under the caption "For Being Mentioned" today.
