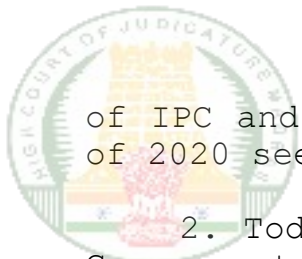
PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C
