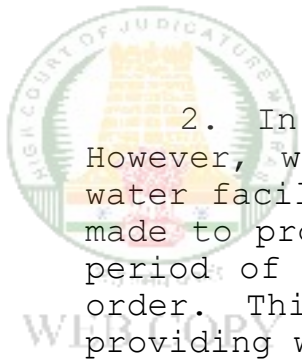

When the matter is taken up for hearing, the learned Special Government Pleader has produced a copy of the proceedings of the second respondent / Block Development Officer that fund has been allotted and work order has been issued. The learned Special Government Pleader further submitted that an administrative order has also been passed by the first respondent / District Collector.



2. In view of the same, this contempt petition is **closed**. However, we find that there is no indication with respect to the water facilities. Adequate facilities in this regard will have to be made to provide water and the needful will have to be done within a period of four weeks from the date of receipt of a copy of this order. This would include either by digging a bore-well or by providing water service and water tap from the nearby overhead tank.
