PRAYER IN CRL A(MD)SR.No.28527 of 2021:

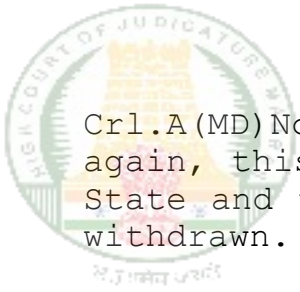
