2. When the matter is taken up for hearing today, Mr.RMS.Sethuraman, learned Additional Public Prosecutor who accepts notice for the respondents 1 and 2 submits that even though the injured person was discharged from the Hospital, totally 12 previous cases are pending against the petitioner, out



of which, 4 cases disposed of, 4 cases pending for trial and 4 cases yet to be taken on file.

3. Considering the facts and circumstances of the case and also taking into consideration the antecedents of the petitioner, this Criminal Original Petition is dismissed as discretionary rating is not available to the petitioner.
