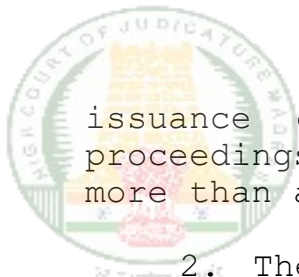

This writ petition has got a checkered history. Action has been in pursuant to the orders passed by this Court on the earlier occasion. Now the grievance of the petitioner is that despite



issuance of notice by the second respondent in and by the proceedings dated 08.08.2019, the same is yet to be concluded though more than a year has lapsed.

2. The learned Counsel for the petitioner submitted that in such view of the matter, it would suffice if the enquiry is directed to be concluded by the second respondent within a reasonable time frame.

3. Considering the above submission, we direct the second respondent to conclude the enquiry initiated in and by the proceedings dated 08.08.2019, within a period of eight weeks from the date of receipt of a copy of this order.

4. With the above direction, this writ petition stands disposed of. No costs.
