Order:This petition coming up for orders on this day, upon perusing the petition filed in support thereof and upon hearing the arguments of M/S.PINAYGASH.I, Advocate for the petitioner and of MRS.S.BHARATHI, Government Advocate(Crl.Side) on behalf of the Respondent, the Court made the following order:-
