Writ Petition is filed under Article 226 of the Constitution of India, praying this Court Directing the 2nd respondent to issue Bulk permit and dispatch ship to petitioner till completion of the quarry lease period of 5 years upto 17.11.2021 as per quarry license given by the 1st respondent in Na.Ka.No.293/Mines/2015 dated 18.11.2016 and quarry lease agreement executed between 1st respondent and petitioner dated 18.11.2016 within a stipulated period.

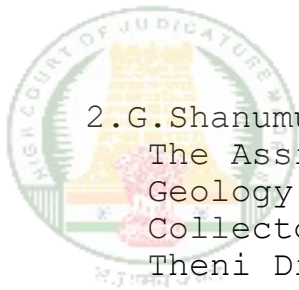
