Learned counsel for the petitioner does not pursue this writ petition any further, in light of the categorical averments in the counter filed by the first respondent, the Chairman, Tamil Nadu Public Service Commission, to the effect that the petitioner has secured 376.5 marks, whereas cut-off mark for BC(G) category, in which, the petitioner falls, is 474.

2.Thus, the petitioner does not fall within the zone of consideration and question of calling the petitioner for oral test and certificate verification does not arise. The mandamus as sought



for is liable to be rejected and I do so. This Writ Petition is thus dismissed. No costs. Consequently, connected Miscellaneous Petition is closed.
