PETITION FOR BAIL Under Sec.439 of Cr.P.C.

PRAYER :-

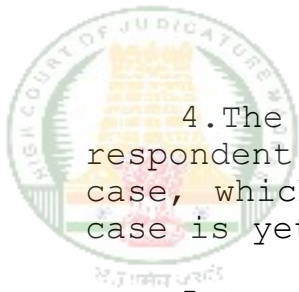
For Bail in Crime No.872 of 2021 on the file of the Respondent police.

ORDER : The Court made the following order :-

The petitioner/accused, who was arrested on 02.10.2021 for the alleged offence under Section 379 IPC r/w Section 21(1) of Mines and Minerals (Development & Regulation) Act, 1957, in Crime No.872 of 2021 on the file of the respondent police, seeks bail.

2. The case of the prosecution is that the petitioner has illegally transported three units of gravel soil by using Tipper Lorry. Hence, the complaint.

3.The learned counsel for the petitioner would submit that the petitioner is an innocent and he has not committed any offence as alleged by the prosecution. However, to show his bona fide, he is prepared to pay a sum of Rs. 4,500/- to the credit of Head Master, Government Higher Secondary School, Y.Othakadai, Madurai District, without prejudice to his case before the trial Court. He would also submit that the petitioner is in jail from 02.10.2021 and hence, he seeks for grant of bail.



4.The learned Additional Public Prosecutor appearing for the respondent would submit that the petitioner is having one previous case, which is not similar in nature and the investigation in this case is yet to be completed.

5.Considering the nature of mineral involved, the antecedents of the petitioner, his willingness to pay a some amount to the credit of Head Master, Government Higher Secondary School, Y.Othakadai, Madurai District and also the period of incarceration, this Court is inclined to grant bail to the petitioner.

6. Accordingly, the petitioner is ordered to be released on bail on his executing a bond for a sum of Rs.25,000/- (Rupees twenty five thousand only) with two sureties, each for a like sum to the satisfaction of the learned Judicial Magistrate No.II, Kovilpatti, Thoothukudi District and on further condition that:

[a] the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity.

[b] the petitioner shall pay a sum of Rs.4,500/- (Rupees Four Thousand and Five Hundred only) as non refundable amount to the credit of Head Master, Government Higher Secondary School, Y.Othakadai, Madurai District (State Bank of India in Account No.10968750674 CIF No.80780349513 IFSC No.SBIN0000253), without prejudice to his defence before the trial Court. The petitioner shall execute the sureties on showing the receipt of the said amount.

[c] the petitioner shall report before the respondent police daily at 10.30 a.m. for a period of 30 days and thereafter, as and when required for interrogation.

[d] the petitioner shall not abscond either during investigation or trial.

[e] the petitioner shall not tamper with evidence or witness either during investigation or trial.

[f] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]**.

[g] If the accused thereafter absconds, a fresh FIR can be registered under Section 229A IPC.
