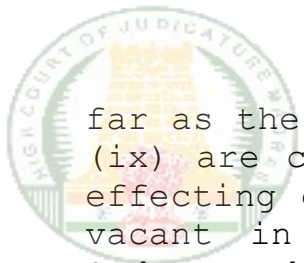

(1D) No.134, School Education Department, dated 18.08.2021 and quash the same in so



far as the clauses in para 4 (I) (c), para 4(I)(V) and para 4(III) (ix) are concerned, and consequently forbear the respondents from effecting compulsory transfer by treating the petitioner's post as vacant in pursuance of the impugned clause in the Government Order, and pass such further or other orders as this Court.
