Today, Mr.K.Selvaganesan, learned Special Government Pleader draws attention to the counter, wherein reference is made to W.P.No.8545 of 2012 filed by P.Sankar, the ninth writ petitioner in this writ petition seeking the same relief as sought for in this writ petition. That writ petition has come to be dismissed and that order has become final. Then, again the same petitioner appears to have filed W.P.No.11074 of 2014 along with six other petitioners seeking the same relief and the aforesaid petition stated to be pending.
