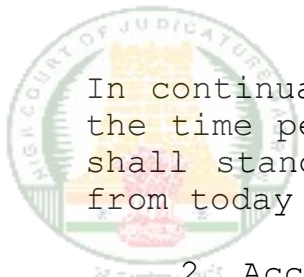
Prayer :-
