When the matter is taken up for hearing, Mr.M.Jeyakumar, learned Additional Government Pleader appearing for the respondents 1 to 3 produced a copy of the proceedings of the Tahsildar, Dindigul (West), in Na.Ka.No.200/2020/A5, dated 05.01.2021, addressed to the Corporation Commissioner, Dindigul Corporation stating that the 4th respondent is a recognised street vendor and in case any proceedings to be initiated as against him, it has to be done only by the Corporation not either by the 2nd respondent or 3rd respondent particularly.



2.In view of the above, the prayer sought for in this writ petition cannot be granted and accordingly, this writ petition is dismissed. No costs. However, it is open to the petitioner to approach the authority concerned in regard to the grievances expressed in this writ petition, if he is so advised.
